Key Findings and Red Flags

1. No Subject Names Listed:

Despite arrest involving three women (Monica, Jane, Crystal), none of their names appear.

?? Legal Concern: Possible redaction or concealment; violation of documentation standards.

2. Single Male Officer Listed:

Only Officer M.J. Howard is listed; no female officer during arrest of women.

?? Legal Concern: Policy violation and civil rights risk.

3. Suspicious Location ? 602 Ford St:

Conflicts with family?s claim of highway-side stop near vape shop.

?? Legal Concern: Possible falsification or incorrect reporting.

4. Incomplete and Generic Fields:

No mention of Narcan, hospital, or medical records. Many blank fields.

?? Legal Concern: Suggests possible tampering or neglect.

5. Evidence of Vehicle Tow but No Processing:

No property inventory or chain-of-custody documentation.

?? Legal Concern: Search and seizure protocol violation.

Inconsistencies with Family Testimony

| Family Account | Incident Report | Conflict |

Legal and Investigative Implications

1. Failure to Document Detainees ? Violates due process and NC records law.

2. Use of Force & Medical Neglect ? Could justify wrongful death claim.

3. Obstruction of Public Records ? Possibly criminal misconduct.
4. Pattern of Abuse ? 10 unexplained deaths since 2019.

Next Recommended Steps

- FOIA Request for:
 - ? Body cam footage
 - ? Dispatch logs
 - ? Booking surveillance
 - ? Records for vehicle BSR3000
- Federal Oversight Request to DOJ, FBI, NC Auditor
- Locate witness Ruby Glaze immediately
